# Our Campaigns

## Tonawanda Coke:

Tonawanda residents continue to advocate for the **former coke plant's redevelopment** after years of air pollution.

## Huntley:

Tonawanda residents are working to **reimagine Huntley**, a former coal plant, as a community resource.

## Lovejoy:

Lovejoy residents have organized to address **the tire dust and noise** produced by **Geiter Done**, a nearby tire disposal facility.

## Seneca Babcock:

Seneca Babcock residents are demanding accountability from **Battaglia Demolition**, a concrete crushing facility that covered their homes in **silica dust** for years.



## American Axle:

Delavan-Grider residents are pushing for the full **remediation of American Axle**, a former auto factory that has leached **toxic chemicals** into their neighborhood.

## Membership Team and Events Committee:

Clean Air members help us build strong coalitions by **organizing outreach and social events** and developing ways to **improve our membership program**.

# Our Impact

## With our members' support, we have:

- Successfully **sued Tonawanda Coke** for violating the Clean Air Act in **2013**
- Established the **Tonawanda Tomorrow** economic action plan to support residents after Huntley's closure in **2015**
- Won **\$3 million** in the NYS budget for **American Axle's** cleanup in **2017**
- Secured a **\$1 million fine** for **Battaglia Demolition's** failure to comply with a court ordered cleanup in **2023**
